RESOLUTION NO. 897

c) Approval of expenditure for sidewalk repairs – Council Member Crisler made a motion to approve ADA-compliant sidewalk replacements in front of the fire station and the coffee shop by Valkyrie Construction for \$16,848, to be paid from REET2 revenues, with \$5,000 to be reimbursed by an RMSA loss prevention grant. Council Member Ashman seconded the motion. There was no discussion. The motion passed unanimously.
